Established in 1949, Howard Memorial Hospital is a 20-bed Critical Access, not-for-profit community hospital. We provide comprehensive medical-surgical care, emergency care and skilled nursing care. Our rehabilitation therapy services department offers the only resistance pool in Southwest Arkansas. Our medical staff includes physicians that specialize in family practice, internal medicine and general surgery.

Because HMH is a not-for-profit and is not required to profits to shareholders return like taxable organizations, we reinvest revenues in excess of expenses to enhance our capacity to deliver highquality health care to the communities we serve. These resources provide for a long-term focus on enhanced technologies, new services and recruitment and retention of outstanding medical professionals. In addition, such resources enable us to provide other services that benefit the community such as health fairs and education to local industry and schools. \$2,770,013 in Charity Care, Private Pay Discounts and the write-off of Bad Debt expense was provided to the community during Fiscal Year 2015.

Compared to other Critical Access Hospitals in the State, HMH tied for 2<sup>nd</sup> in productivity (lowest number of FTEs per Adjusted Patient Day); ranked 4<sup>th</sup> in Net Income from Patient Services; ranked 2<sup>nd</sup> in Average Revenue per Adjusted Patient Day; tied for 4<sup>th</sup> for lowest Bad Debt Expense; 3<sup>rd</sup> place for Days in Accounts Receivable; ranked 3rd in Average Expense per Adjusted Patient Day and 7th for volume (Adjusted Patient Day).
